Shabby Chic Exhibit and Auction 2013

Partnering of the Davie County Arts Council and the Davie Habitat for Humanity and ReStore

This is an exciting joint venture involving two non-profits and the talented arts and crafts community in the Yadkin Valley area. Habitat for Humanity and their ReStore has a mission to provide affordable housing. The Arts Council has a mission of connecting the community to the arts. Combining the efforts of those who build homes, with the efforts of those who make them enjoyable is a natural fit.

Through this project, area artists and craftspeople can showcase their talent and creativity by turning something ordinary into something extraordinary!

What do interested artists do?

- Habitat for Humanity ReStore will allow artists the opportunity to scout for one or more items in the store up to a \$___ value that can be painted, refinished, re-combined or re-purposed in some way. There will be no charge to you. Examples of materials available--windows, doors, tables, chairs, baskets, a variety of hardware, etc. It may take several scouting trips to find the items that “speak” to you.
- Finished pieces can be functional or decorative.
- **December 1, 2012 through April 30, 2013---** Items can be picked up at the ReStore 1035 Yadkinville Road, Mocksville, NC during business hours of 9 a.m. to 5 p.m. Tuesday – Saturday. Mocksville’s ReStore is the only ReStore participating in the “Shabby Chic” art project.
- You will sign a **good faith agreement** at the ReStore with a description of the pieces taken.
- During **May, 2013** you will turn in your finished project(s) to the Davie County Arts Council.
- If you are inspired to create another piece after finishing your first one, a separate agreement will be required.

IMPORTANT NOTE: *If you are unable to complete the project, any unused items or the **value amount** of the original items taken will be returned/reimbursed to the ReStore.*

Completed Art or Craft Work

- **Submissions will be accepted on either Tuesday, May 28 between the hours of 5 p.m.—6:30 p.m. or Wednesday, May 29 between the hours of Noon — 4:00 p.m.** at the Brock Performing Arts Center at 622 North Main Street, Mocksville, NC.
- **June and July, 2013---** Completed pieces will be on exhibit at the Brock Performing Arts Center **Gallery**. *If you create a hanging piece, it must be equipped to hang-- for instance; decorative windows would need screw eyes and chain.*

June and July, 2013 Continued:

Artists are encouraged to bring their business cards or brochures to the gallery to promote their work during the exhibit and to be on hand at the Auction and closing reception on August 3.

- No items will be accepted if coating is tacky or not completely dry to the touch.
- Artist is responsible for delivery of his or her item to the Brock.
- Any item not sold at the auction will be returned to ReStore to be sold at their location in Mocksville.
- Habitat for Humanities will provide to the artist an "In Kind Donation" form for the artist's materials to be listed as a 2013 tax donation. A dollar amount will be filled in by the artist not Habitat personnel.

Exhibit and Auction

- August 3, 2013 at **6 p.m.** until.... A Grand Auction will be held on stage in the theater of the BPAC. All proceeds will go toward building of a Habitat home.
- Minimum value bids will be assigned by the ArtWorks Committee.
- Artists may bid at the auction if they wish to purchase their art.
- Items remaining after the auction will be given to the ReStore and will be available for sale to the community from the store.
- In order to actively bid on items, bidders must register giving your name, address, daytime telephone number. Each bidder will then be given a bidding card with an assigned number to use during the auction.
- Bidder will pay at the check-out table for his or her item (s).

Artist Agreement for Shabby Chic Exhibit and Auction

I agree to apply my skills to fashion a work of art or craft from materials selected at the Habitat for Humanity ReStore that I will deliver to the BPAC no later than **May 29, 2013** between noon and 4:30 p.m. If I am unable to fulfill my agreement I will return all materials or their original cash value to the ReStore no later than April 1, 2013.

I understand that my finished work will be exhibited in the Brock Gallery during June and July 2013 and that on August 3, 2013 the work will be donated for the Grand Auction and proceeds will be donated to the Habitat for Humanity for use in constructing a home in Davie County.

I understand that the Davie County Arts Council has final say over what is exhibited in the gallery and it is possible that work could be eliminated from the project if there is a question involving community standards. I understand reasonable care and caution will be exercised by the Arts Council in the handling of my work, but it is possible for damage to occur and the DCAC is not liable for any such damage.

My work may be photographed and used in publicity by the DCAC.
